This form shall be used by operators/pilots of flights departing in Austria to obtain approval from Austro Control AIS/ARO Wien for the use of STS/ATFMX flow exemption designator in Field 18 of the flight plan. Only with this approval the STS/ATFMX indicator may be filed.

The STS/ATFMX indicator may be filed separately or in combination with other special flight status indicators (HOSP, HUM, STATE, FLTCK, HAZMAT, others) as stated in the request form.

Please note that flights with STS/SAR, STS/HEAD, STS/FFR or STS/MEDEVAC are automatically exempted from flow regulations. An authorisation for flow exemptions need not be requested and the ATFMX exemption designator shall not be stated in the flight plan in combination with SAR, HEAD, FFR or MEDEVAC.

Detailed information regarding the use of special flight status (STS/) indicators may be found in the IFPS Users Manual and the Aeronautical Information Publication Austria, ENR 1.9.
